

ARTICLES OF INCORPORATION

OF

PRO REFERRALS CORP.

SECRETARY OF STATE TALLAHUS TALLAHUS TELORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: PRO Referrals Corp. The principal office of the Corporation is 2250 Spring Lake Circle, St. Cloud, Florida 34771. The mailing address of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.

Article 2. Duration. The duration of the Corporation is perpetual.
