

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is RONALD A. STRUTHERS, P.A., a Florida corporation, and the principal office is located at 189 Albert Lane, Port Charlotte, Florida 33954-3705.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

This corporation shall exist perpetually.
