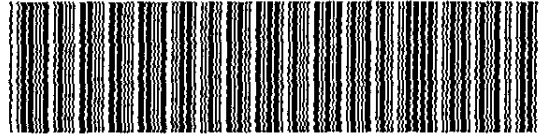

ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

Corporate existence shall commence upon the date of subscription and acknowledgment of these Articles of Incorporation, pursuant to Section 607.167 of the Florida Statutes.




