ARTICLES OF INCORPORATION

OF

NATALIE SHNITSER MD PA

We, the undersigned, all of who are duly licensed to engage in Internal Medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statues and the Florida Professional Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I - CORPORATE NAME AND MAILING ADDRESS

ARTICLE II - DURATION
