

ARTICLES OF INCORPORATION OF AUTO XTREME DETAILING, INC.

I, THE UNDERSIGNED, being a natural person of legal age, acting as incorporator of a corporation under the Laws of the State of Florida, adopt the following articles of incorporation for such corporation:

FIRST: The name of the corporation is Auto Xtreme

Detailing, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to clean & maintain vehicles within the State of Florida and any other

lawful business activity for which corporations

may be incorporated under Chapter 607 of the

Florida Statutes.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1000) shares of common stock having a par value of \$1.00 each.
