

TO THE
ARTICLES OF INCORPORATION
OF
CLEAN WORLD LINEN SERVICES, INCORPORATED

CLEAN WORLD LIEN SERVICES, INCORPORATED, a Florida corporation (hereinafter the "Corporation") is filing these Articles of Amendment to Articles of Incorporation pursuant to F.S. 607.0602. Article IV of the Articles of Incorporation of the Corporation was amended and duly adopted by the Corporation's Board of Directors on the 14 day of April, 2005, was amended as follows:
