**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is TORRES & CABRERA INVESTMENTS, INC.

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The purposes for which the corporation is organized are:

- To engage in the purchase and sale of real and personal property of all types, wherever located.
