


ARTICLES OF INCORPORATION OF VENTURE SEAPLANES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is VENTURE SEAPLANES, INC.

ARTICLE II - PRINCIPAL OFFICE
