The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE I - NAME

The name of this corporation is: SONMAY INC.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by this corporation shall be: primarily to engage in the business of inbound customer A) service . .

to purchase, acquire, hold, sell, assign, transfer, mortgage, pledge, and B) otherwise dispose of the shares of capital stock, bonds, debentures, or other evidence of indebtedness of any corporation, domestic or foreign, and while the holder thereof, to exercise all the rights and privileges of ownership, including the right to vote thereon, and to issue in exchange therefore its own stock, bonds, and other obligations;
