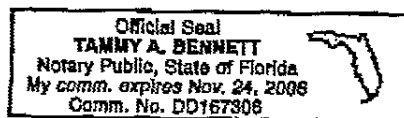
- (1) The name of the corporation is PIPPING GROVES OF POLK COUNTY, INC.
