ARTICLES OF INCORPORATION
OF

ARTICLE I

Name. The name of the Corporation is FLORIDA PULMONARY CONSULTANTS SLEEP RESEARCH DIVISION, INC. (the "Corporation").

ARTICLE II

Principal Office and Mailing Address. The street address of the principal office and the mailing address of the Corporation is 1788 West Fairbanks Avenue, Winter Park, Florida 32789.

ARTICLE III

Business Purpose. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

Capital Stock.
