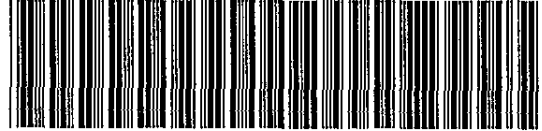

#### ARTICLE XIII Amendment


