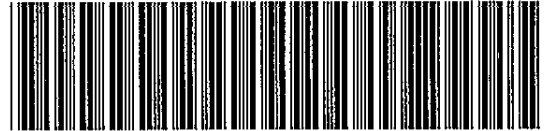

OF

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is BAYSIDE II, INC., and the principal address and principal place of business is 470 - 2<sup>ND</sup> STREET NORTH, SAFETY HARBOR, FLORIDA 34695.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
