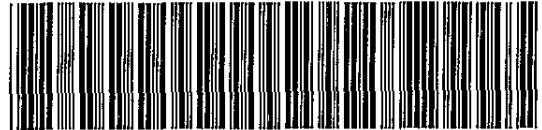

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be TRUE 1 ENTERPRISE, INC.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on JULY 22, 2003 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

Subject to applicable Florida Statutes, every Shareholder, upon the sale of any new stock of the corporation of the same kind, class or series as he or she already holds, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered by others.

ARTICLE V - REGISTERED AGENT

ARTICLE VI - INCORPORATOR

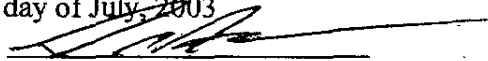
ARTICLE VIII - SHAREHOLDER PROPERTY

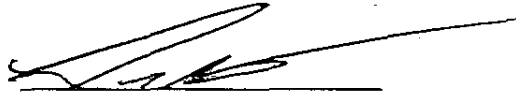
