ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation :

ARTICLE ONE

The name of the corporation is Advance Index Group Inc,

ARTICLE TWO

The duration of the corporation is perpetual.
