ARTICLES OF INCORPORATION

ARTICLE I - NAME

THE NAME OF THIS CORPORATION IS:

HBM TRADING, CO.

WITH THE PRINCIPAL PLACE OF BUSINESS LOCATED AT:

ARTICLE II - PURPOSE


ARTICLE X - BY LAWS
