
ARTICLE X

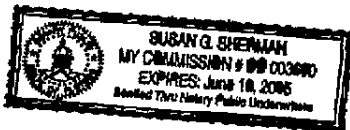


