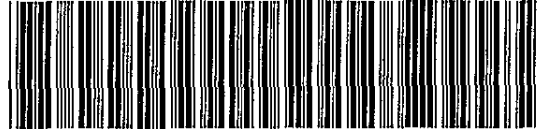

ARTICLE 1 - NAME/ADDRESS

The name of this corporation is **NOLAN TORKELSON LAWN, INC.**, and its mailing and principal office address is 431 Old Main Street, Suite D, Bradenton, FL 34205.


