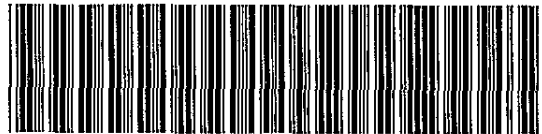

Article I - NAME

The period of its duration is perpetual.
