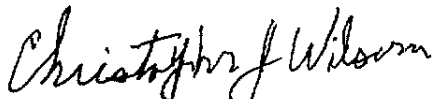

That the undersigned, natural person of the age of at least eighteen (18) years, acting as Incorporator of a Corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation to wit:

ARTICLE I

The name of this Corporation is WILSON & SONS PLASTERING INC.

ARTICLE II

The period of duration of this Corporation shall be perpetual.

The aggregate number of shares which the Corporation shall have the authority to issue is 500 shares. The shares shall have a par value of \$1.00

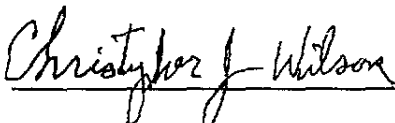
ARTICLE V

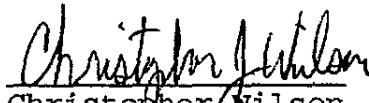

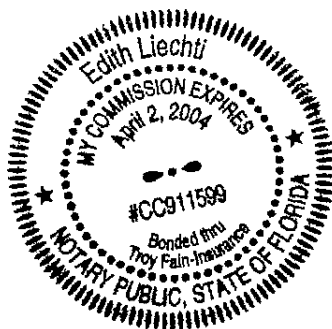
