ARTICLES OF INCORPORATION OF GREG DREXLER PHARMACIST, INC.

ARTICLE I - NAME

The name of this corporation is GREG DREXLER PHARMACIST, INC. The principal place of business of this corporation shall be 2604 NW 69th Terrace, Gainesville, Florida, 32606.
