# ARTICLES OF INCORPORATION

# FOR

THE COFFEE TRADING COMPANY, INC.

### Article I.

# Corporate Name

The name of this corporation is THE COFFEE TRADING COMPANY, INC.

### Article II.

### **Nature of Business and Powers**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

### Article III.

### Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of one dollar (\$1.00) per share.
