

ARTICLES OF INCORPORATION

OF

KENNETH D. OLSON, P.A.

ARTICLE 1 – NAME

The name of this corporation is KENNETH D. OLSON, P.A.

ARTICLE II – DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III – PURPOSE
