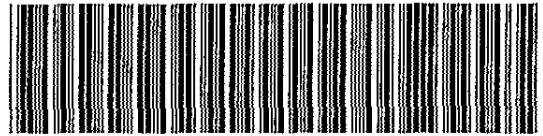

**ARTICLE 1 – NAME**

The name of this corporation is KENNETH D. OLSON, P.A.
