

# ARTICLES OF INCORPORATION OF GUITIAN BROTHERS MUSIC INC.

I, the undersigned, hereby make, adopt, subscribe and acknowledge these. The authorized capital stock of this corporation shall consist of 60 shares of common stock, having \$ 10.00 par value, which shall be issued for such consideration as may be fixed by the Board of Directors of the corporation.

#### ARTICLE IV: INITIAL CAPITAL
