## ARTICLES OF INCORPORATION

### **OF**

### MKSS CORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: MKSS CORPORATION, 800 Pheasant Run Court, Port Orange, Florida 32127.
