Dear Mrs. Mitchell,

I hold a Power of Attorney for the above corporation as well as a signature stamp for the sole shareholder.

In February 2005 I created the check for the payment of the Annual Report along with the downloaded form for filing. I stamped the check with the officer signature and submitted the form with the check to the officer for his signature and mailing.

The form and check were with the same documents for another company owned by the same officer shareholder. Evidently he only signed one of the forms.

When your agency corresponded, in March of 2005 requesting a signature be inserted on the form, I stamped the form with the signature stamp of this officer and mailed it to your agency. I again responded to your agency's additional correspondence in July, informing your agency that I had responded in March, I did not send additional copies of checks or reports at that time. I thought the issue had been resolved at that time.

In February 2006 I tried to download the Annual Report for 2006 only to discover that your agency had dissolved this corporation for non filing of Annual Report.

It was at this time that I requested the front and back of the cancelled check paying the 2005 fee and made a copy of the form from my records. I sent these along with a letter explaining what had transpired and requesting reinstatement without penalty. We received another notice from your agency informing us that the dissolution had been done and that reinstatement would require additional fees. I then corresponded one more time to request the reinstatement without penalty since we had complied with all request.

Per our telephone conversation of yesterday, I am submitting this letter, and a check for the payment of the 2006 fee. I cannot download a report form so I am sending a profile document.
