ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of Forensic Pathology of Southeastern U.S., INC. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on August 1, 2003.

ARTICLE III. PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida to the extent permissible under the laws and rules of the State of Florida.

ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having no par value. The consideration to be paid for each share shall be as fixed by the shareholders, and may be


