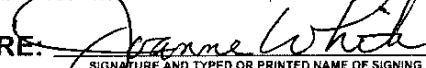

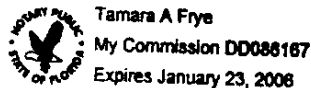
1. Joanne White is the President of **J.M. WHITE ENTERPRISES, INC.**, a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on October 1, 2004.
