

## ARTICLES OF INCORPORATION OF SPICES FOR LIFE, INC.



#### ARTICLE I

<u>Name</u>

The name of the corporation shall be SPICES FOR LIFE, INC.

#### ARTICLE II

**Duration** 

This corporation shall exist perpetually.

#### **ARTICLE III**

**Purpose**
