ARTICLES OF INCORPORATION

ARTICLE I

<u>Name</u>

The name of the corporation shall be JUPITER INVESTMENT ADVISORS, INC.

ARTICLE II

Duration

This corporation shall exist perpetually.

ARTICLE III

Purpose

This corporation is organized for the purpose of engaging in any or all lawful business for which corporations may be incorporated.
