This corporation will engage in the business of yacht brokerage and management services permitted under the laws of the State of Florida and the United States of America.

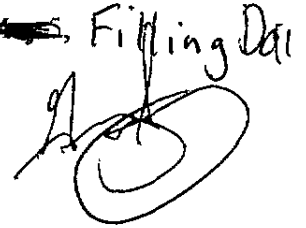
