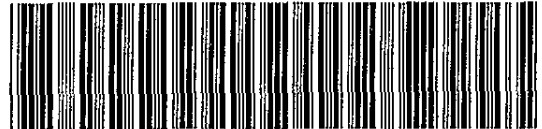

**ARTICLES OF INCORPORATION
OF**

ARTICLE I
