ARTICLE I - NAME

The name of the corporation is FCC Service Co., Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.

The street address of the initial principal office and mailing address of the Corporation is 340 Royal Poinciana Way, Ste. #305, Palm Beach, Florida 33480.


ARTICLE VI - INITIAL BOARD OF DIRECTORS
