

1. Corporate Name

The name of the Corporation shall be: WIN-WIN INC. OF CENTRAL FLORIDA
The principal place of business of this corporation shall be 6018 PARKVIEW DRIVES
ORLANDO, FL. 32821.

2. Registered Agent in Initial Registered Office


