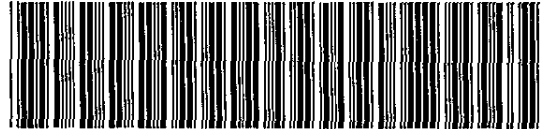

ARTICLE I. NAME

The name of the corporation shall be **MOREA MAPS & MANAGEMENT, INC.**

ARTICLE II. PRINCIPLE OFFICE

The address of the principle office of this corporation is 5532 Split Oak Court, Tallahassee, Florida 32303; the mailing address of this corporation is Post Office Box 180490, Tallahassee, Florida 32318.

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to conduct business in, have one or more offices in, and to buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida, and in all other states and countries.
