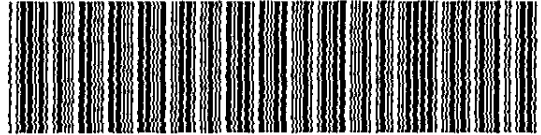

Name**
