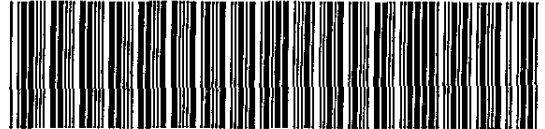



ARTICLES OF INCORPORATION OF
MAIL AND DETAILS, INC.**


Mail and Details, Inc., a Florida corporation (the "Corporation"), adopts the following articles of amendment to its articles of incorporation pursuant to the provisions of Section 607.1006, Florida Statutes:

1. The text of the amendment as adopted is as follows:

BE IT FURTHER RESOLVED that . . . Article I of the Corporation's Articles of Incorporation shall be amended to change the name of the Corporation to "M&D Liquidation, Inc."

2. The date of adoption of the amendment was March 31, 2006.
3. The amendment was adopted by a duly approved shareholder action in accordance with the provisions of FSA § 607.1003.
