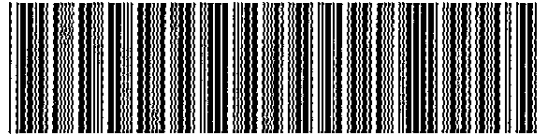

The undersigned hereby agrees to organize a corporation in accordance with Chapter 617, Florida Status ( the " Florida General Corporation Act " ) as follows:

**ARTICLE I. NAME**

**ARTICLE II. CORPORATE EXISTENCE**


