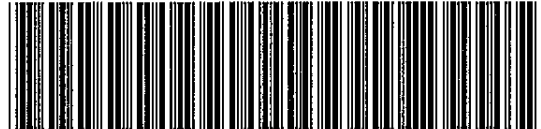

ARTICLE III PURPOSE

- A.
