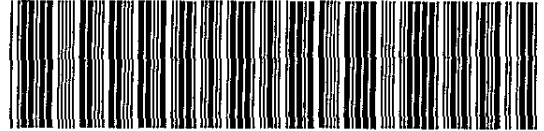



**ARTICLES OF INCORPORATION**  
**OF**  
**DAS MASONRY INC.**

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("the Corporation") is DAS Masonry Inc.

**ARTICLE II**

The street address and mailing address of the principal office of the Corporation is 90 S.E. Forest Street, Keystone Heights, Florida 32656.

**ARTICLE III**

The Corporation is authorized to issue Fifty Thousand (50,000) shares of common stock having a par value of One Cent (\$.01) per share.

**ARTICLE IV**

The street address of the Corporation's initial registered office is 160 Magnolia Avenue, Keystone Heights, Florida 32656. The initial registered agent for the Corporation at that address is James J. Taylor Jr.

The Corporation shall indemnify its directors and officers to the fullest extent permitted by law.


