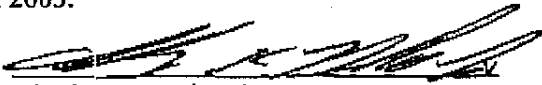
ARTICLE VI. AMENDMENT

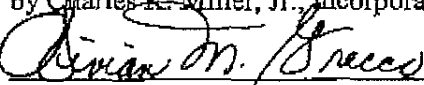
