ARTICLES OF INCORPORATION OF

ARTICLE I - NAME AND ADDRESS: The name of this corporation shall be XID, Inc., with its mailing address being 800 E. Broward Blvd, Suite 700, Fort Lauderdale FL 33301, and its principal address being 800 E. Broward Blvd, Suite 700, Fort Lauderdale FL 33301.

ARTICLE II - NATURE OF BUSINESS: This corporation may engage in any activity or business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.


