I sent a letter to this office on Sept 8<sup>th</sup> explaining our situation and received a reply on Sept 22.

I subsequently talked to a gentleman in your office and he advised me to write and explain why it is impossible to pay the full amount at this time.

As I said in my Sept 3<sup>rd</sup> letter, the corporations in question had no income in the year of 2003...

I have enclosed 3 checks for \$150.00 each drawn on the account of Custom Accents Inc. dba Decorating Masters Institute for the filing fee. Each of these 4 companies are wholly owned by Ron and Rita Warner.

Decorating Masters Institute is a school that teaches Faux Finishing, Decorative Painting, and other art skills. Since the hurricanes the class attendance is less then 20% of normal. We are struggling to pay our rent and utilities just to stay in business. We have applied for a SBA business interruption loan to help bridge this loss of business gap.
