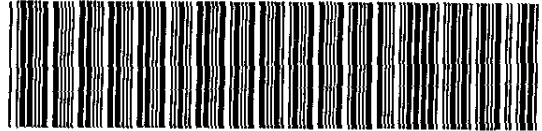



The undersigned hereby makes, subscribes and organize and incorporate a business for profit under the laws of the State of Florida Statutes, Chapter 607.

ARTICLE I - NAME

The name of the corporation is ELUSIVE QUALITY, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business is to provide construction clean-up work.

ARTICLE III - DURATION & EXISTENCE

The duration of this corporation shall be perpetual. Corporate existence shall commence immediately upon the subscription and acknowledgement herein to be followed by the filing of the Articles of Incorporation to the Department of State within the five days as allowed by Florida Statute 607.167.
