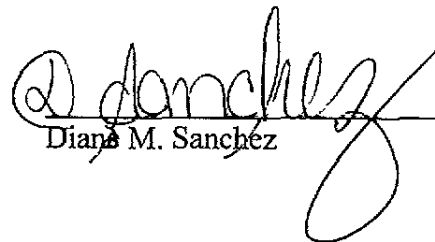

ARTICLE VII. BY-LAWS

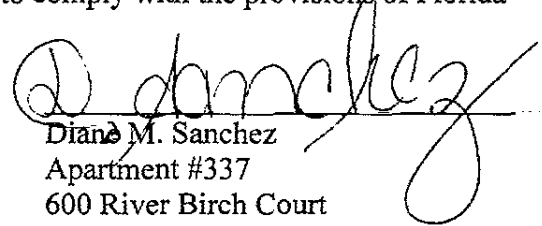
The power to adopt, alter, amend, or repeal by-laws will be vested in the shareholder.
