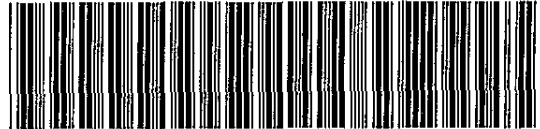

The undersigned, for the purposes of forming a Corporation under Section 607.164 of the Florida General Corporation Act, do hereby certify as follows:

Article I

Corporate Name and Address

The name of the Corporation is **DEFINITE BODIES, INC.**, and the street address of the Corporation is:

Article II

Corporate Purposes

The Corporation is organized to function as **WORK OUT CENTER** and any related business services and to otherwise engage in any activity or business permitted under the laws of the United States of America and in the state of Florida.



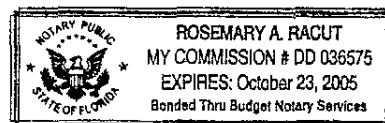
