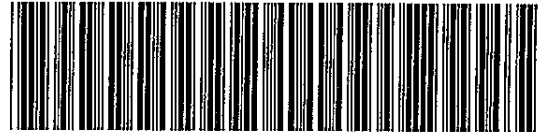



The undersigned Subscriber, who is licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act (F.S. Chapter 607) and the Florida Professional Service Corporation and Limited Liability Company Act (F.S. Chapter 607), hereby adopts and files with the Secretary of State of the State of Florida these Articles of Incorporation.

ARTICLE TWO

PRINCIPAL OFFICE OF CORPORATION

SEVERANCE AND TERMINATION OF EMPLOYMENT

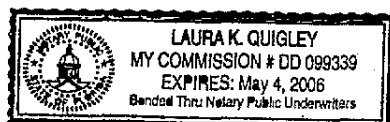


