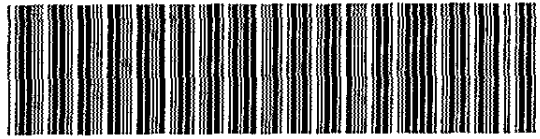

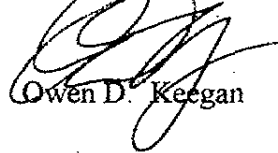

**ARTICLES OF INCORPORATION
OF
TRIAD CAPITAL GROUP, INC.**

Pursuant to Chapter 607 of the Florida Statutes, the undersigned natural person, Keith Teelucksingh, acting as incorporator, hereby executes the following Articles of Incorporation and sets forth:

ONE

The name of the Corporation is Triad Capital Group, Inc.

TWO

ker The principal place of business and mailing address of the corporation is 19555 Estuary Drive, Boca Raton, Florida 33498.

THREE

The Corporation is organized for the purpose of engaging in any lawful business as may be conducted under applicable law, including the Law of the State of Florida.

FOUR

The Corporation shall have one class of stock, which shall be Common Stock, and which shall have both voting rights and rights to distribution of the assets of the Corporation upon liquidation. The number of shares of stock which the Corporation is authorized to issue is five thousand (5,000), which stock shall have a par value of one cent (\$0.01) per share.

FIVE

ker The initial Board of Directors shall have one (1) member. Keith Teelucksingh, whose business address is 19555 Estuary Drive, Boca Raton, Florida 33498, shall act as the sole Director until the first meeting of the Shareholder(s) of the Corporation, or until his successor(s) is/are duly chosen and qualified. The number of Directors may be changed from time to time in such a lawful manner as the Bylaws of the Corporation may provide.

SIX

ker The name of the initial registered agent of the Corporation is Keith Teelucksingh, a natural person who is a resident of the State of Florida and is the initial director of the Corporation. The address of the initial registered agent and the initial registered office of the Corporation is 19555 Estuary Drive, Boca Raton, Florida 33498.

SEVEN

The incorporator is Keith Teelucksingh, whose address is 19555 Estuary Drive, Boca Raton,

EIGHT

The Board of Directors is hereby empowered to authorize the issuance from time to time of shares of its stock, now or hereafter authorized, for such consideration as the Board of Directors may deem advisable, subject to such limitations and the restrictions, if any, as may be set forth in the Bylaws of the Corporation.

NINE

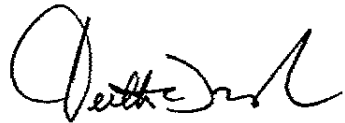
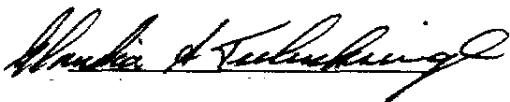
The duration of the Corporation shall be perpetual.

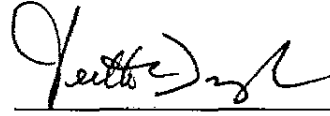
