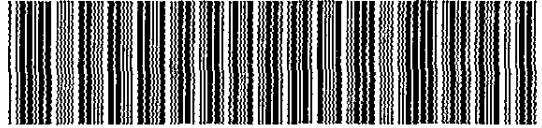

EXISTANCE:


